Books & Materials Fees are due by Enrollment day. \$100 per student is non-refundable.* If we are notified on or before June 1st that your child/ren will not be attending, all fees in excess of \$100/student will be refunded. After June 1st and before August 1st, 25% of the total fees will be refunded. On or after August 1st, no refund will be issued. The Field Trip Fee yearly total is broken into ten equal payments spread over the course of the year for the convenience of parents; these are not meant to represent payment per month enrolled. If, for any reason, a child does not complete the school year, the account balance is due in full.

Enrichment Program Fees

Fees for enrichment programming, such as music lessons, school clubs and classes, before and after school camps, sports, etc., are due at the time of registration and monthly thereafter for activities with recurring charges. Participation in enrichment activities for students with an account over 30 days past due may result in suspension of participation, and/or loss of space in the program.

Pre-School Tuition

The school annually sets the tuition and fee rates after teacher salaries and classroom costs for the following year are projected. Tuition is charged on a yearly basis and school enrollment constitutes an agreement to pay the yearly total. Tuition may be paid: 1) in one yearly payment; 2) in two installments due August and November; or, 3) in ten installments automatically withdrawn August – May 1, with an additional 5% accounting charge.

All fees and the first tuition payments are due by Registration Day and a payment plan for the year may be set up at that time. Paperwork can be completed during registration to set up automatic withdrawals for families choosing the monthly payment plan. Tuition payments will be deducted on the first of each month unless payment has already been received. The yearly total is broken into ten equal payments spread over the course of the year for the convenience of parents; these are not meant to represent payment per month enrolled.

A twenty-dollar late fee will be charged on the second day of any month in which tuition is not paid and again on the fifteenth if it is still delinquent. If, for any reason, a child does not complete the school year, the account balance is due in full.

NSF & Late Payments

There will be a twenty-dollar fee for any NSF payments. Accounts over 30 days past due will be charged 5% of the account balance each month until current and may result in collection activities. Fees incurred as a result of collection activities will be the responsibility of the parent/guardian.
